As I mentioned earlier regarding TTA PG702, WiBro Standard had reached full alignment between WiBro Standards and a subset of the P802.16-2004/P802.16e-2005. Moreover, TTA PG702 has a plan to develop standards reaching full harmonization with IEEE 802.16m for IMT-Advanced of ITU-R and IEEE 802.16/REV2 for the revision of WiBro standard.

Meanwhile, at this time, we would like to seek permission from you to adopt some materials from IEEE 802.16 such as P802.16REV/2, EMD/SRD/SDD of TGM and so on. If there is any particular formality to deal with issue, please let us know it. Meanwhile, the many members of TTA PG702 will be participating in

the future IEEE 802.16 sessions for our collaboration continuously.

I hope this letter is useful for you to understand the new TTA PG702 status and I believe we can provide more information in the future.
