Thank you for your liaison response and sharing of materials for RIT proposals. We are glad to hear your positive response to closer cooperation between TTA PG702 and IEEE802.16.

Regarding RIT submission, TTA PG702 has planned to finalize the RIT proposals by mid-September, which will be considered for submission to ITU-R by TTA or Korean Administration. Moreover, we encourage the members of TTA PG702 to participate actively for preparation of RIT proposals at IEEE802.16m and also are willing to reflect the outcome into TTA's RIT proposals.

Recently, TTA PG702 also formed the ad-hoc working group to draft the RIT proposal. It is chartered to develop RIT proposals based on IEEE802.16m and to develop the response to any future request for ITU-R activities.

We greatly appreciate your information for IEEE802.16 session #63 at Jeju. Most of our members in TTA PG702 are expected to join the meeting, so as to support the activities of IEEE802.16. During the time, especially, we would like to coordinate the schedule for RIT submission and to discuss the future activities toward a productive response to ITU-R consensus building.
