# Working Party 5D

## LIAISON STATEMENT TO INDEPENDENT EVALUATION GROUPS (COPY TO IMT-ADVANCED TECHNOLOGY PROPONENTS) FOR FINAL EVALUATION REPORTS

### Background

Working Party 5D had received at its October 2009 meeting six candidate technology submissions for IMT-Advanced.

As part of the on-going process for IMT-Advanced, the period from October 2009 (the 6<sup>th</sup> meeting of Working Party 5D) to June 2010 (the 8<sup>th</sup> meeting of Working Party 5D) has been designated for evaluation of the IMT-Advanced candidate technology submissions by Independent Evaluation Groups.

WP 5D received 13 final evaluation reports and 2 additional Reports from 13 registered Independent Evaluation Groups on the candidate IMT-Advanced technologies before the 8<sup>th</sup> meeting in June 2010. WP 5D thanks all the Independent Evaluation Groups for providing these reports, and acknowledges that the reports are good references for the assessment of the compliance with the minimum requirements.

Through this liaison, WP 5D considered that Step 4 and Step 5 of the IMT-Advanced process were closed at the 8<sup>th</sup> meeting of WP 5D.
