After reading the section of 11.9.23, I think the section includes other erroneous statements.

1. The title should be changed from Pre-PAK to Encrypted Pre-PAK, as this TLV is about 128 byte long Encryted Pre-PAK, not the 256 bit-long raw Pre-PAK.

2. This PAK (Primary Authorization Key) is 16 byte quantity, from which ann AK, KEK, two MAC message authentication keys, and two EAP message protection keys are derived.

à this statement should be changed to as indicated:

Pre-PAK (pre-Primary Authorization Key) decrypted from Encrypted Pre-PAK is 256 bit quantity.

3. Also, reference is incorrect. Reference should be 7.2.2.2 instead of 7.x.

For your information, this Encrypted Pre-PAK TLV type 35 appearing 11.9.23 will be used in PKMv2 RSA-Reply message.
