

Figure 1 shows the high level WiMAX network reference model. OSS/BSS (Operation Support System / Business Support System) and WiMAX network elements are connected over the Internet that form the "all IP" networks. The reference model supports both mobile and fixed broadband wireless access.

14 15 16 A TMN (Telecommunications Management Network) model has been proposed by the ITU and TeleManagement Forum (TMF) to structure OSS/BSS management functions and define interfaces between the functional entities. 


Figure 2: WiMAX OSS/BSS Reference Model
