Purpose

Amend text for Section 6.3.3.8.2 "Transmission using station CID" in order to provide a method for streamlining MPDU transmission and reducing overhead when a tunnel is not present.

Amendment Text

Add the following text to Section 6.3.3.8.2 "Transmission using station CID"

Intermediate RS's shall concatenate MPDUs from various CID's in the same PHY burst when those CID's share the same next hop (from viewpoint of transmitting intermediate RS).
