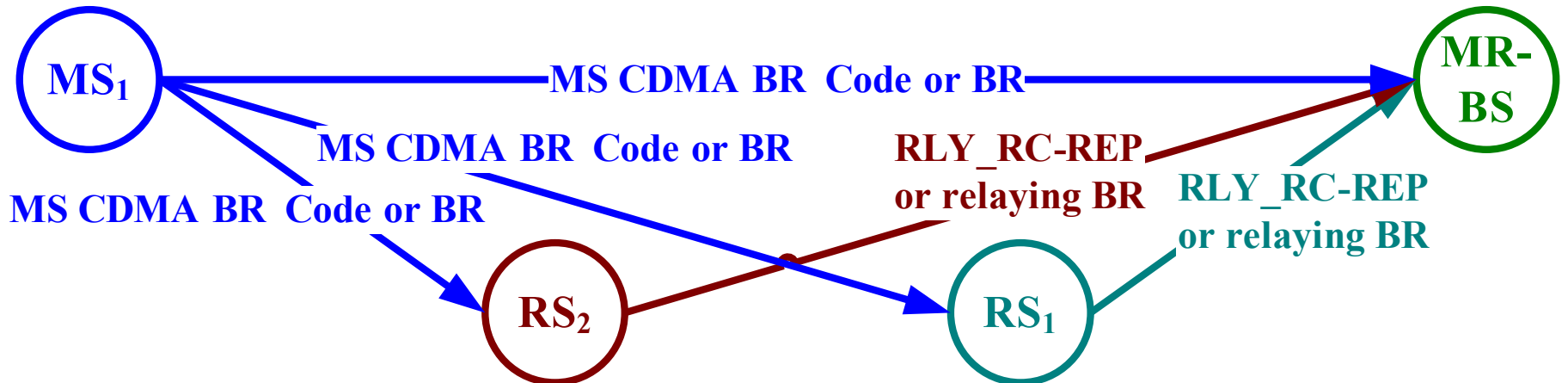
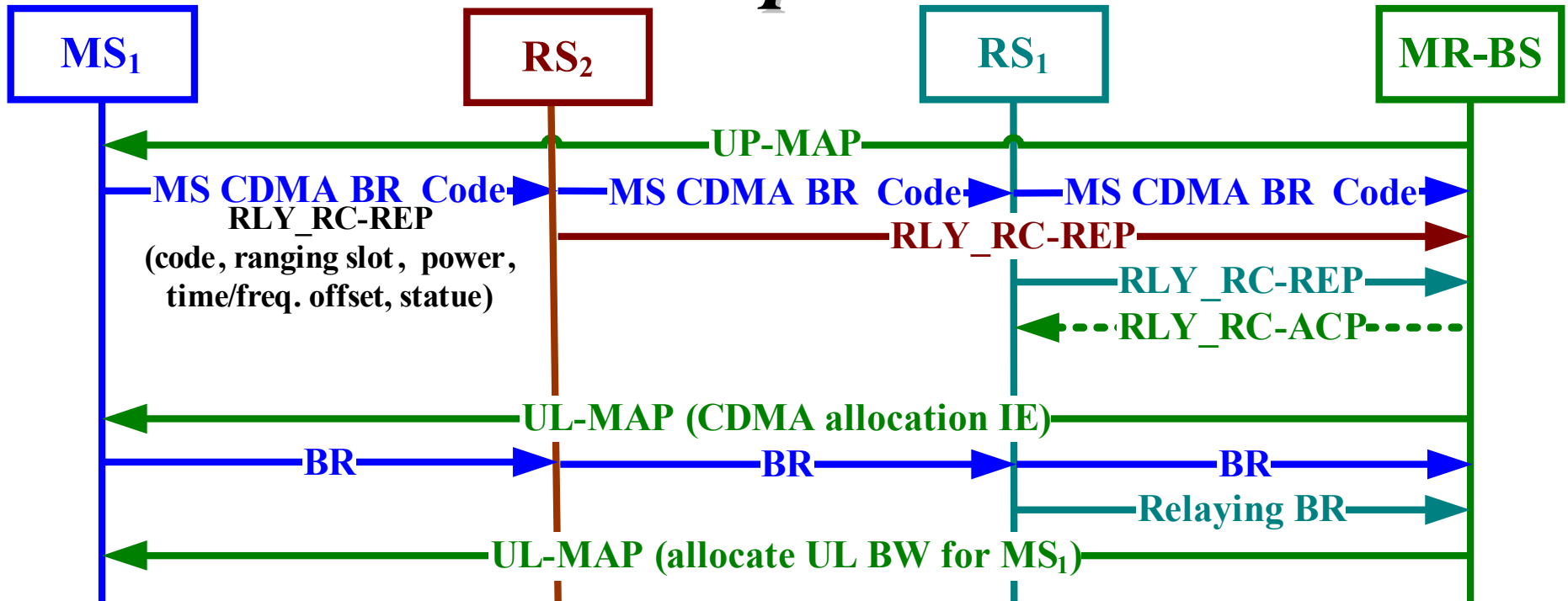

- The RS shall support MS CDMA-based bandwidth request procedure without any modification on MS
- The MS CDMA-based bandwidth request procedures should be centrally controlled by the MR-BS
