Comments on the proposed schedule in IEEE C802.16mmr-06/018

- Not easy to complete all system requirements, the selection procedure, and 802.16j TOC at one meeting
 - Note that the upcoming May session is the 1st meeting for TG j
- The proposed phased process may not be effective
 - Most of all technical items are closely related with one another
 - Better to discuss all related technical items together
- May need more time to present/select all technical contributions
 - It can be considered that the selection/merging process goes till November
 - The detailed procedure how to arrange shall be decided in TG meeting
- ❖ Note that any schedule/procedure of TG cannot be decided at SG meeting
