IEEE 802.16 Task Group 4 met for the IEEE 802.16.4 Session #12 from March 11-14 in Hilton Head. In particular, comments are requested on Section 6.2.8 that discusses ARQ. Comments are due by May 11, 2001. The commentor must email the comments directly to the Task Group 4 email reflector (mailto:stds-802-16-tg4@ieee.org).

The prefix "TG4 STRAWMAN COMMENT:" MUST appear on the subject line of the message. Attachments are not permitted. Comments regarding graphics, figures, drawings and tables must

be fully described in text form. If such graphic-oriented comments can not be rendered or described in text form, the commentor may submit a document using the IEEE 802.16 template [http://ieee802.org/16/docs/802\\_16\\_template.doc](http://ieee802.org/16/docs/802_16_template.doc). The document must be addressed to [marks@nist.gov](mailto:marks@nist.gov), with a copy to TG4 MAC Chair Ken Peirce at [ken@malibunetworks.com](mailto:ken@malibunetworks.com). A followup comment can refer to the document by number.

If multiple comment forms are sent in one message, each comment form must contain all of the fields filled out as required (see above), including the commentor's name.

All of the proposed changes (comments) will be integrated into a new document for discussion at Session 13. Submissions will be considered non-confidential and will be posted for public access on the TG4 area of the IEEE 802.16 Web Site.

For consideration at the upcoming Session 13, valid comments that follow these instructions must be received no later than Friday, May 11, 2001.
