

Task Group Review/Call for Comments: Project 802.16/Conformance03

Radio Conformance Tests (RCT) for 10-66 GHz WirelessMAN-SC™ Air Interface

Deadline: 14 July 2003

On 20 March 2003, the IEEE-SA Standards Board approved Project Authorization Request (PAR) P1802.16.3 (renumbered on 12 June as P802.16/Conformance03. The PAR [<http://standards.ieee.org/board/nes/projects/1802-16-3.pdf>](http://standards.ieee.org/board/nes/projects/1802-16-3.pdf) is entitled “Draft Standard for Conformance to IEEE Standard 802.16 – Part 3: Radio Conformance Tests (RCT) for 10-66 GHz WirelessMAN-SC Air Interface.” It has the scope statement:

This standard represents the Radio Conformance Test (RCT) specification for base stations and subscriber stations based upon the WirelessMAN-SC (10-66 GHz) air interface specified in IEEE Standard 802.16.

802.16’s Task Group C [<http://WirelessMAN.org/tgc>](http://WirelessMAN.org/tgc) has been assigned to develop the draft. Task Group C plans to create a first draft by the end of Session #26 [<http://WirelessMAN.org/meetings/mtg26>](http://WirelessMAN.org/meetings/mtg26) in July 2003 and open a Working Group Letter Ballot immediately thereafter.

At Session #25, Task Group C reviewed contribution C1802.16.3-03/01, received in response to a Call for Contributions. Based on that review, the Task Group decided to revise it and issue a Call for Comments, with the intent of using it as the basis of the first draft. Therefore, **Task Group C is currently conducting a Task Group Review by issuing this Call for Comments on Contribution C1802.16.3-03/01r1** [<http://ieee802.org/16/tgc/C3/contrib/C1802163-03_01r1.pdf>](http://ieee802.org/16/tgc/C3/contrib/C1802163-03_01r1.pdf).
