

Call for Comments on Project 802.16m Requirements: IEEE 802.16 Advanced Air Interface

Deadline: 12 March 2007, 12:00 noon (Orlando, FL time)

Introduction

Task Group m <<u>http://ieee802.org/16/tgm</u>> of the IEEE 802.16 Working Group is responsible to develop a draft standard under the P802.16m PAR approved on 6 December 2006: <<u>http://standards.ieee.org/board/nes/projects/802-16m.pdf</u>>

At the first Task Group m (TGm) session, during 802.16's Session #47 in January 2007, an initial set of mobile system requirements (IEEE 802.16m-07/002) was developed. Additional inputs on these requirements were solicited via a Call for Contributions IEEE 802.16m-07/004r1

A TGm Requirements Drafting Group was established during Session #47, with the charter to consolidate and, where possible, harmonize all the requirements contributions received from the Call for Contributions and create a single Requirements document for the Task Group to review during Session #48. The Drafting Group also prepared an "information only" compilation document C802.16m-07/058 http://ieee802.org/16/tgm/contrib/C80216m-07 058.pdf>

that incorporates all submitted contributions in a minimally-edited form.

TGm now solicits specific comments on C802.16m-07/076 for discussion and potential adoption during Session #48.

Comments should refer to the "Ballot ID" as "tgmreq" and the "Document under Review" as "C802.16m-07/076".

Contributions should be included only if the proposed remedy is so substantial as to require the contribution format for appropriate presentation. Any contribution shall be referenced by an appropriate comment. Make use of the "TGm" upload directory at <<u>http://tgm.wirelessman.org</u>> to post comments and contributions.

This is not a ballot, so please do not attempt to vote 'Approve' or 'Disapprove'. This is a Call for Comments to improve the document and prepare it for eventual adoption by the Task Group.
