A web-based survey was conducted during the November 2002 Plenary to assess the views of 802 attendees on a number of issues relating to Plenary meeting arrangements. This report presents the results of that survey. Each survey question is presented followed by the response to the question. There were 337 individuals that responded to the survey. There were 868 paid attendees at the November 2002 Plenary meeting.


