**Minutes of Teleconference using tentative agenda doc.: IEEE 802.11-99/178**

Ballot results and issues (Stuart J. Kerry):

We still have one unchanged negative comment from Jeff Fischer.

One new editorial comment from Hitoshi Takanashi (who was asked to input this by Naftali Chayat, who is not in the balloting group). This was:

In Annex G of the IEEE P802.11a /D7.0,

- Replace “##” with “k” in Table G.8 and G.18.
- Replace “##” with “j” in Table G.9 and G.21.

IEEE position (Stuart J. Kerry):

We would need to go to the 3<sup>rd</sup> re-circulation since it was submitted as a comment even though it was minor editorial.

Taking account of the ballot information and the position from IEEE, the new comment was withdrawn by the commenter Hitoshi Takanashi since this change is a very minor editorial. Therefore, we will not need to go to the 3<sup>rd</sup> re-circulation.

Motion #1: Move to forward P802.11a D7.0 to RevCom without any changes.

Any other business:

Jeff Fisher (who submitted a negative comment previously) sent an email August 2, 1999 (0650hrs. EST) to Naftali saying: “As I explained in my email after our telephone conversation, I would change my no vote to a yes pending your suggested change in text to “typical values of amplifier backoff are 5-9 dB”.”

The group felt that it is not an official submission and that it was after the official closure of the ballot. But it was noted by the group and motioned.

Motion #2: Move to reject Jeff Fisher's suggestion to add typical backoff values (5-9 dB).
