Results of correspondence activities

4. ITU-R WP 8F (sharing with IMT-2000 in the band 2500-2690 MHz)

- **"ACTION:** IEEE 802.16 members should provide inputs to the ITU-R Liaison Officer (José Costa) before 20 June 2005 with the objective of completing the proposed contribution to ITU-R WP 8F for consideration and approval at the IEEE 802.16 meeting (#38) in July 2005."
