Introduction

At the Opening Plenary of the IEEE 802.16 Working Group's Session #59, Reza Arefi, Acting as Chair of the ITU-R Liaison Group, presented an opening report (IEEE L802.16-09/0003), including lists of background documents and input contributions, proposed objectives for the meeting, and the draft agenda for the ITU-R Liaison Group meeting.

Results of the ITU-R Liaison Group meeting

Agreed Objectives for Session #59

During the opening plenary of 12 January 2009, the group agreed to the following Objectives for Session #59:

- 1. Review 802-approved ITU-R contributions from session #58
- 2. If necessary, update and seek approval for replacements
- 3. Draft and issue Call for Contributions for TDT (including LBT), SCT, SPECT
- 4. Prepare "Statement of Intent" to 802.18 TAG, per page 8 of IEEE L802.16-08/079
- 5. Update workplan regarding IMT-2000 and IMT-Advanced activities in 2009 as appropriate
- 6. Review input liaison statements, prepare responses, and communicate with other groups as appropriate

Objectives 1 & 2: Review and update 802-approved contributions

On Objectives 1 & 2, we reviewed the two 802-approved contributions (L802.16-08/070 and L802.16-08/071r1). The group decided that document L802.16-08/070 did not require any updates. We, however, identified an editorial issue with document L802.16-08/071r1 which we fixed. As a result, this document was updated (L802.16-08/071r2). The WG Chair should inform IEEE's ITU liaison of the change once agreed by the WG.

Objective 4: Statement of Intent to 802.18 TAG

The group developed and approved a letter to 802.18 TAG expressing the WG's intention to submit a proposal for IMT-Advanced (L802.16-09/0006r1).

Motion: To approve L802.16-09/0006r1 and authorize the WG Chair to forward it to 802.18 TAG.

Objective 5: Workplan Update

ITU-R Liaison Group reviewed the workplan (L802.16-08/058r1), made updates, and created a new revision (L802.16-08/058r2).

Motion to the WG closing plenary:

Motion: To approve updated workplan (L802.16-08/058r2).

Objective 6: Liaison statements

On this objective, the ITU-R Liaison Group reviewed two liaison statements received from the WiMAX Forum and prepared responses.
