Subject: Liaison statement of 3 September concerning IMT-Advanced submission

Dear Professor Kang,

The IEEE 802.16 Working Group (WG) appreciates the constructive dialog with the TTA delegation to the *Joint ARIB, IEEE, and TTA Leadership Meeting for IMT-Advanced* of 30 August, and it also appreciates TTA's excellent hospitality regarding the arrangement. We believe that this meeting advanced the opportunities for our ongoing cooperation.

The WG would like to report to you the outcome of its [Session #63](#) (31 August – 3 September in Jeju, Korea) regarding the IMT-Advanced proposal submission.

As per our communication on IEEE's preparations for IMT-Advanced submission, as well as in accordance with the IEEE 802.16 ITU-R Liaison Group Workplan ([L802.16-08/058](#)), we have the necessary documentation for the IMT-Advanced submission nearly completed at this session. The IEEE 802.16 WG prepared the following drafts of IEEE's IMT-Advanced submission documents:

- L802.16-09/0101r1: [DRAFT] SUBMISSION OF A CANDIDATE IMT-ADVANCED RIT BASED ON IEEE 802.16 (PART 1)
- L802.16-09/0102r1: [DRAFT] SUBMISSION OF A CANDIDATE IMT-ADVANCED RIT BASED ON IEEE 802.16 (PART 2)
- L802.16-09/0103r1: [DRAFT] SUBMISSION OF A CANDIDATE IMT-ADVANCED RIT BASED ON IEEE 802.16 (PART 3)
- L802.16-09/0104r1: [DRAFT] SUBMISSION OF A CANDIDATE IMT-ADVANCED RIT BASED ON IEEE 802.16 (PART 4)

Please note that the IMT-Advanced related drafts mentioned in earlier liaison statements are obsolete.

We will submit these documents for broader IEEE review, to conclude during our [Session #63.5](#) (21 – 24 September in Hawaii, USA). We will share with your organization our final IMT-Advanced submission package for your consideration once it has been agreed by the IEEE 802.18 Radio Regulatory Technical Advisory Group.

We would appreciate a status report from your liaison official at our [Session #63.5](#). We also continue to appreciate comments from the TTA members regarding IEEE P802.16m standard development as well as our preparations for IMT-Advanced submission.
