## 2. Problem Statement

These editorial corrections are required In Figure D.8 of Annex D.2.

- a. Min-sleeping interval and Max-sleeping interval are not defined in sleep mode operation. Those should be Initial-sleep window and Final-sleep window, respectively.
- b. In the left side of the figure start frame of the first sleep window is incorrect. The first sleep window should start at the frame where the LSBs of the frame number is the same as Start frame defined in MOB SLP-RSP.
- c. The starting arrow of the second sleep window is not consistent with description in 6.3.21.2. The starting arrow of the second sleep window should be aligned with the end of the listening window. Also, the size of sleep window should be counted from the last expiration of listening window according to 6.3.21.2 and Figure 130a. So description on it appearing in the figure should be corrected as well.




Figure D.8 – Example sleep mode – BS initiated
