Meeting Minutes

The Conformance Task Group (TGC) of 802.16 met during the IEEE 802.16 Session #41 at the Maurya Sheraton Hotel in New Delhi, India to resolve the comments from the Letter Ballot Recirculation for P802.16/Conformance04/D5 #18d held from Dec. 13, 2005 to Jan. 4, 2006. Herbert Ruck acted as interim chair. The TGC met on January 10, 2006 from 8:30 AM-11:30 AM and on January 12, 2006 from 8:20 AM- 8:45 AM.

Fourteen people attended (S. Probasco, R. Marks, P. Elmdahl, G. Cummings, R. Juluri, J. Schmidt, P. Joo, V. Yanover, D. Castelow, A. Wieczorek, S. Migaldi, W. Mulder, E. Ben-Tovim, and H. Ruck). A total of seven comments were received during letter ballot recirculation. One additional comment was added during the meeting (comment number 008). Four comments were technical binding, one technical non-binding, and three editorial.

The comment resolutions are shown in the commentary database IEEE 802.16-06/001r2.

After the meeting, the chair contacted the authors of the technical binding comments explaining the resolution by the group and received verbal assurance that the authors with binding-technical comments will vote YES on the ballot.

The group made the motion to approve the commentary database, authorize the editor to create a new version D6 of the PICS and submit the document to further letter and sponsor ballots as needed.

Several people could not log their attendance due to server problems.
