IEEE Std 802.3.1-2013REV Task Force meeting convened at **08:00 AM (all times in MST)**, Monday, June 24, 2024 by Marek Hajduczenia, Task Force Chair.

Marek Hajduczenia reviewed the agenda in [https://www.ieee802.org/3/2/a/public/202403a/agenda\\_d2\\_202403a\\_r02.pdf](https://www.ieee802.org/3/2/a/public/202403a/agenda_d2_202403a_r02.pdf).

Mr. Hajduczenia asked if there were any modifications to the agenda, none responded. Mr. Hajduczenia then asked if there was any objection to approving the agenda, none responded, and the agenda was considered Approved by unanimous consent at **08:06**.
