- Displays transfer function describing new 120uH minimum channel requirement
- Displays transfer function with 350uH and Alt-A Midspan PSE
- Displays potential transfer function with 350uH Alt-A Midspan PSE and 120uH PD

- Discussion to clarify the reason for exploring new transfer functions
- Graph showing that 0.2dB is the worst case difference between 350uH and 120uH PD in these latter two system topologies
- Summary recommendations: If Alt-A Type 2 Midspan is regulating Iunb to Type 1 levels, Eq 33-19 is not needed as the system meets 350uH transfer function. If Alt-A Type 2 Midspan is not regulating Iunb to Type 1 levels, Eq 33-19 needs to be met
- Text modification: Append "or meet 33.4.9.2" to end of 1st paragraph of 33.4.8.
- Perhaps adding a requirement for additional 0.2dB margin on Midspans would satisfy all margin requirements for all systems.
- The consensus of the group is for presenter to solicit input from PHY vendors on their level of comfort with the proposal.
