A. Vetteth presented proposed textual changes to D4.0's treatment of Clause 30 and LLDP to align D4.1 with P802.3bc.

- Vigorous debate on whether any management attributes need to remain in the PD Basic Package
- In general, LLDP can be implemented independent of SNMP management.
  However, some features, such as aPDReducedOperationPowerValue, seem to
  make SNMP mandatory when implementing LLDP.

Agreement to move the entire oPD object to the PDLLDP object, but generally people are not comfortable accepting the text without detailed review.

Instruct the editor to move the entire current PD attributes to be the PD LLDP objects. Instruct the entire current LLDP related PSE attributes to be the PSE LLDP objects. Make other related editorial changes to coordinate with IEEE P802.3bc D2.0.
