

Meeting Minutes: IEEE P802.3dq Task Force

November 25, 2025 Off cycle Interim teleconference Session

The IEEE P802.3dq Task Force meeting was convened at 11:05am November 25, 2025 by the Task Force chair, Jason Potterf.

The meeting was held electronically, attendance is listed in Appendix A.

Mr Potterf displayed and proceeded to review the agenda in [Meeting Agenda](#).

The agenda was approved at 11:08am by unanimous consent.

IEEE SA Patent Policy, Mr Potterf showed the patent slides. The call for patents was made at 11:10am and no one responded.

It has been discussed in the past that the DQ TF would mostly use teleconferences to complete the work, allowing attendees to participate without required meeting fees or travel expenses. January offers a unique opportunity to have some key stakeholders in the same room and the chair asked if there were any objections to having a meeting during the interim week in January. None responded.
