

- Draft 3.0: 38 unsatisfied comments from 5 commenters
 - Mostly (36 comments) from 4 commenters on PLCA issue from WG ballot 33 from 2 commenters who commented in WG ballot on related issues
- Draft 3.1: 8 unsatisfied comments on draft 3.1 from 1 (existing disapprove) commenter
- Draft 3.2: 6 unsatisfied comments on draft 3.2 from 2 (existing disapprove) commenters
- Draft 3.3: 7 unsatisfied comments on draft 3.3 from 3 commenters
 - 4 from one existing disapprove commenter, 3 from two new, all are related to MDI connector specification
