This listing will include:

- Participants full legal name AND,
- Visa application number AND,
- Passport country of issuance.

**IRCC Privacy:** Information collected as part of these participant lists is used to identify and coordinate the processing of visa applications and, upon request, provide organizers updates of aggregate data on the status of visa applications of event participants within the confines of the *Privacy Act* and at the discretion of the Special Events Unit.

**Visa Application #** If you do not have an application number at the time of registration, please complete your registration and enter this information when you have it by returning to the registration site and logging in with the 'Already Registered' button.
